

# PRIVACY STATEMENT Zonderland Constructie B.V.

Zonderland Constructie B.V., with its registered office in Joure (8502 TZ) at De Koevorde 6, hereinafter referred to as "Zonderland Constructie B.V.", is committed to the responsible handling of the personal data of its visitors. Zonderland Constructie B.V. will process your personal data carefully and with due observance of the provisions of the Personal Data Protection Act and the General Data Protection Regulation in this regard. In this Privacy Statement, Zonderland Constructie B.V. informs you on the manner in which Zonderland Constructie B.V. processes your personal data and how you can change or object to it. ## Article 1 Explanation of personal data and specific purposes for the processing thereof

### 1. Purpose

### 2. Orders

This allows us to deliver your order and to keep you posted on the progress. Zonderland Constructie B.V. also submits these data to third parties in case this is required for your order, such as to delivery services and to our distribution facility. ### 3. Your account

### 4. Newsletters

Because you have purchased a product from us as a customer, or because you have subscribed to our newsletter, you are included in our mailing list. ### 5. Post-payment
